1 (Start time: 10:00 a.m.) 2 PROCEEDINGS CHAIRMAN LEARA: Call the April 17 10:00 a.m. 3 4 meeting to the Missouri Gaming Commission to order. 5 Angie, please call the roll. 6 MS. FRANKS: Commissioner Hane. 7 COMMISSIONER HANE: Present. 8 MS. FRANKS: Commissioner Conway. 9 COMMISSIONER CONWAY: Present. 10 MS. FRANKS: Commissioner Boulware. 11 COMMISSIONER BOULWARE: Present. MS. FRANKS: Commissioner Finney. 12 13 COMMISSIONER FINNEY: Present. 14 MS. FRANKS: Chairman Leara. CHAIRMAN LEARA: Present. 15 All right. - 1 Please call the roll.
- 2 COMMISSIONER FINNEY: Mr. Chairman, I have an
- 3 objection to read into the record before you call the
- 4 roll.
- 5 CHAIRMAN LEARA: Go right ahead, Mr. Finney.
- 6 COMMISSIONER FINNEY: Yes. Thank you.
- 7 Pat, can you hear me okay?
- 8 THE COURT REPORTER: Yes.
- 9 COMMISSIONER FINNEY: I am hereby objecting
- 10 to this closed session pursuant to Section 610.002.6,
- 11 Revised Statutes of Missouri, and this objection shall
- 12 act as an absolute defense to any claim filed against me
- 13 pursuant to Section 610.027.
- 14 Furthermore, I am hereby abstaining from
- voting on any motion pending before this Commission
- 16 until such time as there has been an investigation into
- 17 the chairman of this Commission and the results of that
- 18 investigation are released to the public.
- 19 My reasons for this position are the
- 20 following: The chairman has alleged he has evidence
- 21 that information was wrongfully withheld from him before
- 22 he voted on a motion but has refused to disclose the
- 23 source of that information to me.
- I take this as a direct personal attack and a
- 25 sign that he is or will be taking a position that I have

- 1 engaged in some sort of misconduct at the Missouri
- 2 Gaming Commission, which I categorically reject. I want
- 3 to know who is the source of these allegations against
- 4 me and the Missouri Gaming Commission and why the
- 5 chairman is protecting or refusing to release the name
- of this individual to myself and the rest of the
- 7 commissioners.
- 8 Second, the chairman has made material
- 9 misrepresentations to myself and the other commissioners
- 10 during the last closed meeting.
- 11 He had demanded the resignation of the deputy
- 12 director without the knowledge or consent of the
- 13 Commission. This came to my attention through the
- 14 executive director, and I spoke directly with the deputy
- 15 director who confirmed this fact.
- 16 When I asked the chairman why he made this
- 17 decision and if he had someone else in mind, he said
- 18 that he had never requested the resignation of the
- 19 deputy director, which I take to be a misrepresentation
- 20 of the fact.
- 21 Third, he has moved for the termination of a
- 22 mid-level employee at the Gaming Commission, Missouri
- 23 Gaming Commission, during a closed meeting and that
- 24 motion was seconded and there was a vote after
- 25 discussion on that motion. The chairman was voted down

- 1 four to one. The motion did not pass.
- 2 The results of that vote were not released
- 3 after a Sunshine request pursuant to the counsel of a
- 4 member of the Department of Public Safety, not the
- 5 counsel -- the general counsel for the Missouri Gaming
- 6 Commission.
- 7 I am concerned that this has exposed me
- 8 personally to liability pursuant to 610.002.6 and as
- 9 such am objecting to this particular closed session and
- 10 abstaining for the reasons I stated.
- 11 In sum, this chairman has withheld the source
- 12 of allegations that I did not have all of the facts
- 13 necessary for a vote before I cast it. This chairman
- 14 has withheld and misrepresented material facts to me,
- 15 potentially caused me to incur personal liability.
- 16 Finally, I wish to be clear on this point. I
- 17 have never cast a vote as a commissioner on the Missouri
- 18 Gaming Commission without being in possession and
- 19 knowledge of all of the material facts necessary for my
- 20 deliberation and determination of that vote.
- 21 I will take legal action against any person
- 22 or entity who make the statement in my opinion in any --
- 23 who make the statement in any form which I determine to
- 24 be defamatory against me related to my diligence and
- 25 record of public service.

1	And that's all I have.
2	CHAIRMAN LEARA: Angie, please call the roll
