## POSITION SUMMARY

This position will supervise a team responsible for conducting in-depth financial investigations on individuals and corporations who are applying for or holding a gaming license. The investigation will yield an analysis of the financial status and suitability of the corporation and/or the individual.

Responsibilities include:

- Supervising and conducting financial investigations. Examining and analyzing corporate structure, history, net profit and loss, income sources, operating budgets, affiliates/subsidiaries, legal litigation and other related areas to assess the entity's financial suitability for a gaming license;
- Analyzing current and past financial data and performance;
- Analyzing and evaluating debt and equity issuances, bank financings and mergers and acquisitions;
- Preparing reports on, projections and forecasts based on this analysis;
- Evaluating current capital expenditures and depreciation;
- Identifying and analyzing trends in financial performance;
- Providing financial models and forecasting;
- Working in concert with general counsel and Missouri State Highway Patrol background investigators;
- Preparing and delivering presentations to the Commission;
- Supervising the Financial Investigation Unit comprised of full-time and part-time financial investigators.

## QUALIFICATIONS

Five years of professional financial experience with a governmental agency (regulatory preferred) or a private sector accounting, finance or brokerage firm, with at least two years of significant financial analysis experience. Supervisory experience is required.

AND

A Bachelor's degree from an accredited college or university with an emphasis in Finance, Accounting, Economics, Business Administration or a closely related area, including or supplemented by at least thirty hours of accounting coursework. Although not mandatory a master's degree, Certified Public Accountant (CPA) and/ or Chartered Financial Analyst (CFA) is desired and preferred.
