

**MINORITY BUSINESS ENTERPRISE (MBE) AND WOMAN
BUSINESS ENTERPRISE (WBE) AFFIDAVIT**

The Missouri Gaming Commission's Regulations require vendors that claim MBE/WBE status to provide either a current MBE/WBE certificate, or attest that they meet the qualifications for MBE/WBE certification prior to allowing business transactions with that vendor to count towards the licensee's MBE/WBE goals. Vendors should complete this form to attest that their company is not certified as a MBE/WBE but it meets the qualifications for MBE/WBE certification as outlined below.

1. Is at least fifty-one percent (51%) owned by one or more individual(s) who are a minority or women; or, in the case of a corporation or other business entity, in which fifty-one percent (51%) of the stock or membership is owned by one or more minorities or women; and whose management and daily business operations are controlled by the minority or woman individual(s) who own it; or
2. Is a sole-proprietorship wholly owned and controlled by a minority or a woman.
3. Owned means having all the customary incidents of ownership, including the right of disposition, and sharing in all risks and profits commensurate with the degree of ownership interest.

4. The minority or woman owner(s) of the business possesses the resources and the requisite expertise to operate effectively in the firm's field of work and the minority or woman owner(s) controls the day-to-day operations of the business.
5. The minority or woman owner(s) has not acquired ownership via a transfer from a nonminority, spouse, relative or employee within one year of creation of the Company.
