## 1 PROCEEDINGS 2 CHAIRMAN ZIMMERMAN: Good morning, and welcome, 3 everyone, to the December 6 meeting of the Missouri Gaming 4 Commission. If you'll indulge me for just a moment this 5 morning, I'm reminded that I tend to only recognize fallen First Responders on the west side of the state since that's 6 7 where I'm from. With that said, I'd like to begin this morning by having just a moment of silence for Correctional 8 9 Officer Kelly Rolando who was killed just before our last 10 meeting in October in a vehicle crash on the 54 bypass in 11 Mexico, Missouri. 12 [MOMENT OF SILENCE OBSERVED] 13 CHAIRMAN ZIMMERMAN: Thank you all. I'll call the December 6, 2023, Missouri Gaming 14 15 Commission meeting to order. Angie, would you please call the ro11? 16 17 MS. FRANKS: Chairman Zimmerman? 18 CHAIRMAN ZIMMERMAN: Present. 19 Commissioner Conway? MS. FRANKS: 20 COMMISSIONER CONWAY: Present. 21 MS. 4	SERGEANT MASTERS: Good morning, Chairman Zimmerman and
5	Commissioners. Missouri State Highway Patrol Investigators
6	and MGC Financial Analysts conducted comprehensive background
7	investigations on Key and Level I applicants. The
8	investigations included, but were not limited to, civil,
9	criminal, financial, and general character inquiries which
10	were made in the jurisdictions where the applicants lived,
11	worked, and frequented.
12	The following applicants are being presented for your
13	consideration.
14	James Matthew Bulen, IT Manager, IOC-Boonville, Inc.
15	Dean Bruce Lane Junior, Director of Slot Operations,
16	Horseshoe St. Louis.
17	Investigative findings were provided to MGC Staff for
18	their review and are available to answer any questions you
19	might have. Thank you.
20	CHAIRMAN ZIMMERMAN: Are there any questions for
21	Sergeant Masters?
22	COMMISSIONER HANE: I'm not sure whether this is for
23	Sergeant Masters or for the Judge, but I understand that Dean
24	Lane was issued a temporary license on 12-12 of '22 and it
25	doesn't expire until 12-31 of '24. So we're looking at him

for another Level I license; correct? I was trying to figure out why we're doing it basically a year ahead of his expiration.

JUDGE RICHARDSON: Because when we issue them a temporary license, it's temporary until such time as the investigations can be complete at which time we bring it before you at that point in time, not at the expiration of a temporary license. So we issued them the temporary so that they can act and do their duties, but then we try to complete that investigation as expeditiously as possible and bring that before the Commission.

COMMISSIONER HANE: Okay. So if we authorize the license today, then it will be good until '25; right? Two years?

JUDGE RICHARDSON: It will always go back to the date of the issuance of his temporary license. The reason for that is once we issue them a temporary license, they basically can do all of the acts and duties of the position for which they are applying, so it will always be the date that any license was issued, whether that was the initial -- or I'm sorry, the temporary, or if there was no temporary, then it would be the initial license.

COMMISSIONER HANE: Okay. So we're doing this in the -- if we approve this, then his license will still expire next year?

1	JUDGE RICHARDSON: Yes.
2	COMMISSIONER HANE: So then we'll be doing it again
3	next year on relicensure.
4	JUDGE RICHARDSON: Yes. Then thereafter, every two
5	years.
6	COMMISSIONER HANE: Thank you. So good job.
7	SERGEANT MASTERS: Thank you.
8	CHAIRMAN ZIMMERMAN: Sergeant Masters, I do have a
9	question for you. I noticed in your investigation there was
10	some issues that came up with Mr. Bulen in your investigation,
11	some things that maybe weren't originally revealed. Just a
12	quick question about does he have a valid driver's license at
13	this time?

15	McTheeney. He's the one that investigated that case.
16	SERGEANT MCTHEENEY: Sergeant Jason McTheeney, Missouri
17	State Highway Patrol. As far as a valid license today, I have
18	not ran him to know if he is valid today.
19	CHAIRMAN ZIMMERMAN: Well, I knew that there were a
20	couple of things that came up during the investigation that
21	had impacted that so
22	SERGEANT MCTHEENEY: Correct.

The supplier license for Everi Payments and the key 17 business entity license for Everi Holdings are scheduled to 18 expire on December 31, 2023. 19 The supplier license for Everi Games and the key 20 business entity license for Everi Games Holding were set to 21 expire on April 30, 2024, but the company's licenses were 22 aligned this month to renew together in the future. 23 Missouri State Highway Patrol Investigators and 24 Missouri Gaming Commission Financial Analysts conducted 25 relicensing investigations consisting of a financial review,

1	feedback from Missouri casinos, jurisdictional inquiries, and
2	a review of disciplinary actions, litigations, and the Key
3	Persons associated with each company.

1 presentation. MS. WIEBERG: Good morning, Chairman and Commissioners. 2 3 My name is Kylee Wieberg, and I'm the Financial Investigations Manager with the Missouri Gaming Commission. Under Tab I, we 4 have request for waiver of institutional investor for up to 20 5 percent ownership from Allan Gray Australia Party Limited. 6 7 Allan Gray is an Australian-based investment company who 8 primarily invests in stocks listed on the Australian Stock 9 Exchange. 10 Allan Gray is a private asset manager who is ultimately 11 owned by the Allan and Gill Gray Foundation. Allan Gray has 12 approximately 10.2 billion assets under management. Allan 13 Gray currently holds 7.1 percent of Ainsworth Game Technology. 14 I'd be happy to answer any questions you may have. 15 CHAIRMAN ZIMMERMAN: Ms. Wieberg, I know that we've 16 discussed this in past presentations about the waivers of institutional investors. Do you know their original 17 18 percentage when they were granted the waiver back in 2001? Or 19 in 2021, I'm sorry. 20 MS. WIEBERG: I do. They originally were granted a 21 waiver for 7.63 percent in 2021. 22 Thank you. CHAIRMAN ZIMMERMAN: 23 MS. WIEBERG: Uh-huh. 24 CHAIRMAN ZIMMERMAN: Are there any other questions for 25 Ms. Wieberg? Seeing none, thank you. I move to approve

1	Resolution 23-083 for Allan Gray. Is there a second?
2	COMMISSIONER HANE: Second.
3	CHAIRMAN ZIMMERMAN: Any further discussion? Seeing
4	none, Angie, would you call the roll?

17	waiver for institutional investor for up to 20 percent for AWM
18	Investment Company, Inc. AWM is registered as an investment
19	advisor with the SEC. AWM is a private company owned by three
20	individuals.
21	AWM is a hedge fund for eight clients with
22	discretionary assets under management of approximately 843
23	million. AWM currently holds 5.42 percent of Century Casinos,
24	Inc.

I'd be happy to answer any questions you may have.

1	CHAIRMAN ZIMMERMAN: I do have a question. In the
2	resolution, the second paragraph of the resolution, it states
3	that AWM has stated that it may acquire interest in Century
4	Casinos, but obviously they already own a percentage. Am I
5	just not reading that correctly, that they may have an
6	interest; or is there interest in increasing that percentage,
7	I guess, is maybe the way that the resolution was worded.
8	MS. WIEBERG: I can't speak on the resolution, I may
9	refer that to legal; but as it states, they do currently hold
10	an interest in Century Casinos at the 5.42 percent and can go
11	up to 20 percent.
12	CHAIRMAN ZIMMERMAN: And they've owned that percentage
13	since the waiver was originally issued in 2021 as well?
14	MS. WIEBERG: They previously held it for 5.01 percent
15	in 2021.
16	CHAIRMAN ZIMMERMAN: All right, thank you. Are there
17	any other questions for Ms. Wieberg? Seeing none, I move to
18	approve Resolution 23-084 for AWM Investment Company. Is
19	there a second?
20	COMMISSIONER CONWAY: Second.
21	CHAIRMAN ZIMMERMAN: Any further discussion? Angie,

8	CHAIRMAN ZIMMERMAN: The next item on today's agenda is
9	Consideration of a Request from Bonnie Sue Lawson for Removal
10	from the Involuntary Exclusion List. General Counsel Heather
11	Richenberger will make the presentation.
12	MS. RICHENBERGER: Good morning, Chairman,
13	Commissioners. Today I'm presenting for your consideration
14	the request of Bonnie Sue Lawson to be removed from the
15	Missouri Gaming Commission's Involuntary Exclusion List. The
16	Commission placed Ms. Lawson on the Involuntary Exclusion List
17	on December 2, 2009. She was placed on the Exclusion List
18	following her 2008 plea of guilty to one felony count of theft
19	of government funds in the United States District Court for
20	the Western District of Missouri.
21	Ms. Lawson had embezzled approximately \$118,000 from
22	Buchanan County while she was employed as the public
23	administrator for the county. Ms. Lawson admitted that she
24	had used some of the funds she embezzled for gambling.

This is Ms. Lawson's second request to be removed from

1	the Exclusion List, with her first request denied by the
2	Commission in January of 2021 with the Commission noting
3	Ms. Lawson still had approximately \$30,000 in restitution
4	owing to Buchanan County.
5	Ms. Lawson's current request was submitted via letter
6	to the Missouri Gaming Commission on August 16 of 2023.
7	Ms. Lawson's request asks the Commission to consider the fact
8	that it's been 14 years since she was originally placed on the
9	Exclusion List, and since that time she has satisfied all
10	court requirements related to her case that resulted in her
11	exclusion.
12	Lawson has served a 37-month federal prison sentence
13	for her embezzlement and has also completed a three-year term
14	of federal supervised release. As of November 22 of 2021, she
15	has now paid in full her court-ordered restitution in the
16	amount of \$119,063.18.
17	Ms. Lawson has indicated she's requesting removal from
18	the Exclusion List so she can patronize her local casino and
19	socialize with friends.
20	Missouri Gaming Commission Staff did recommend to
21	Ms. Lawson that she appear today before the Commission.
22	Ms. Lawson has indicated she was unable to travel, citing that
23	she lives in St. Joseph, Missouri, is 83 years old and has a
24	multitude of health conditions which make traveling the
25	distance to Jefferson City difficult. Accordingly, Ms. Lawsor

1 is not here today. 2 To the extent I'm able, I am happy to answer any 3 factual questions the Commission might have on this matter. 4 CHAIRMAN ZIMMERMAN: Are there any questions for 5 Ms. Richenberger? COMMISSIONER CONWAY: Thank you for your investigation 6 7 into this incident. All the conditions of her probation and parole that were established by the Court, have all of those 8 issues been sufficiently satisfied? 10 MS. RICHENBERGER: That is the understanding of the Missouri Gaming Commission, and we did make contact with the 11 12 US Attorney's Office in the Western District of Missouri who 13 did confirm that the restitution had been paid in full. 14 There's also a Satisfaction of Judgment that has been filed in 15 that criminal case. 16 COMMISSIONER CONWAY: Since I'm so personally involved 17 in this issue, I just wanted to make it clear that it's always 18 been my understanding that when a person serves their 19 probation and patrol, that their individual rights are 20 returned to them. I would state in the State of Missouri, 21 once she had satisfied that, she was eligible to register to 22 vote, she's also able to vote in the jurisdiction and has been 23 given her rights under those conditions. 24 Personally, I would like to say that this is one issue 25 where compulsive gambling is a responsibility of the MGC to

1	offer services and some of the funds that we retrieve from the
2	casino industry to assist those who have determined that they
3	have issues with gaming.
4	Needless to say, that she no longer has access to any
5	state or federal monies that she was eligible to oversee in
6	her position as the public administrator, having those two
7	conditions and the fact that she has sufficiently served her
8	term in the federal institution and also she has completed all
9	of her issues with her parole and probation with the Western
10	District Court, I think at this time I personally am going to
11	vote in favor of this resolution, so if the Chair would allow
12	or make the resolution, I would be happy to second it.
13	CHAIRMAN ZIMMERMAN: Thank you, Commissioner Conway.
14	Any other questions or comments? Thank you. I move to
15	approve Resolution 23-085 for removal from the Involuntary
16	Exclusion List for Bonnie Sue Lawson. Is there a second?

4	Number 23-085.
5	CHAIRMAN ZIMMERMAN: Thank you, Ms. Richenberger.
6	The next item on today's agenda is Approval of
7	Resolution 23-086, Final Orders of Rulemaking, 11 CSR 45-5,
8	five rules contained in Exhibit A. Melissa Stephens will be
9	making that presentation this morning.
10	Ms. STEPHENS: Thank you. Good morning, Chairman
11	Zimmerman, Commissioners.
12	Under Tab L, we have a group of five Final Orders of
13	Rulemaking for amendments that were identified during the
14	Gaming Commission's recent periodic review of the rules
15	contained in 11 CSR 45. These amendments address various
16	cleanup items, including the ongoing updates to class
17	designations to identify the licensee intended to be
18	referenced in the rule, updates to terminology for consistency
19	with the statutes as well as throughout 11 CSR 45,
20	typographical corrections for consistency with other
21	regulations, and the removal of duplicative and outdated
22	elements.
23	In addition, these amendments also include revisions
24	that have been requested by staff and industry, generally to
25	clarify the regulations. All of the Final Orders of

1	Rulemaking for your consideration are found in 11 CSR 45-5.
2	The subsections for the record are as follows: .030, .100,
3	.140, .150, and .235.
4	These amendments were proposed at the August 30, 2023,
5	Commission meeting, and you approved moving forward with the
6	proposed rule amendments. The public comment period ended on
7	November 1, 2023, and the public hearing was held November 2,
8	2023. No public comments or testimony were received.
9	On November 22, 2023, we received approval from the
10	Governor's office to proceed with these Final Orders. Pending
11	your approval, these amendments would become effective on
12	March 30 of 2024.
13	CHAIRMAN ZIMMERMAN: Any questions for Ms. Stephens?
14	Do you frequently do you ever get comments, anybody come
15	forward?
16	MS. STEPHENS: We have a very detailed process that we
17	do in drafting the rules, and we try to address the industry
18	comments before we ever bring them to you the first time. So
19	it is our goal to not have those comments come up, but we have
20	on occasion.
21	CHAIRMAN ZIMMERMAN: Well, you do a great job. Thank
22	you, Ms. Stephens.
23	MS. STEPHENS: Thank you.
24	CHAIRMAN ZIMMERMAN: Any other comments or questions?
25	Thank you. I move to approve Resolution 23-086. Is there a

20	Licensure for Renato Ascoli. Mr. Ascoli's renewal was
21	originally on our agenda for the October meeting. The
22	background investigation had been complete, and there were no
23	issues.
24	Prior to that meeting, MGC was advised that Mr. Ascoli
25	was no longer on the board, so we pulled his renewal. Come to

1	find out, while Mr. Ascoli is no longer on the Board of IGT
2	Global Solutions, he is still on the Board of International
3	Game Technology, Incorporated, one of our licensees.
4	Staff requested and Chairman Zimmerman approved
5	extension of Mr. Ascoli's license on November 9, 2023.
6	Mr. Ascoli was on your agenda today under Tab D for renewal of
7	his Key Person license, and that license was renewed. Staff
